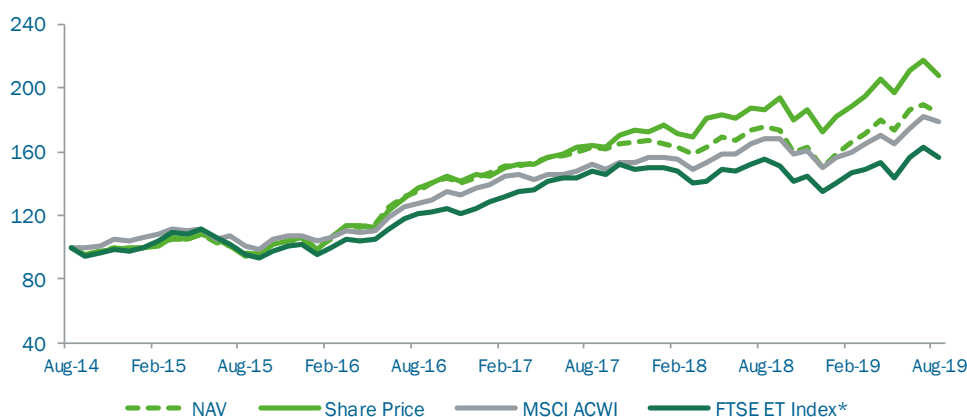


INVESTMENT OBJECTIVE

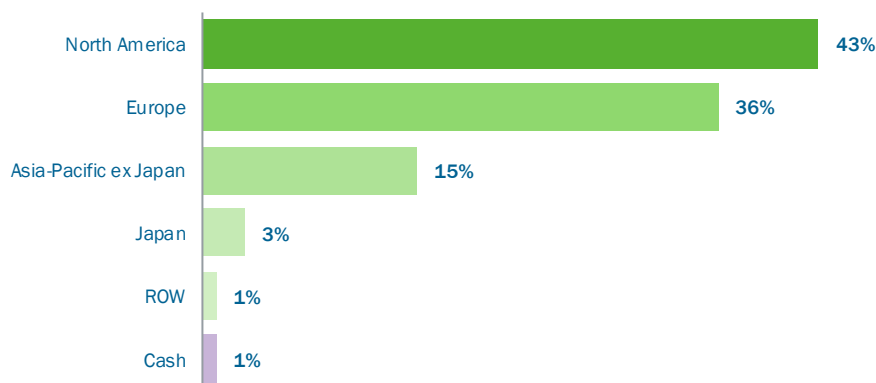

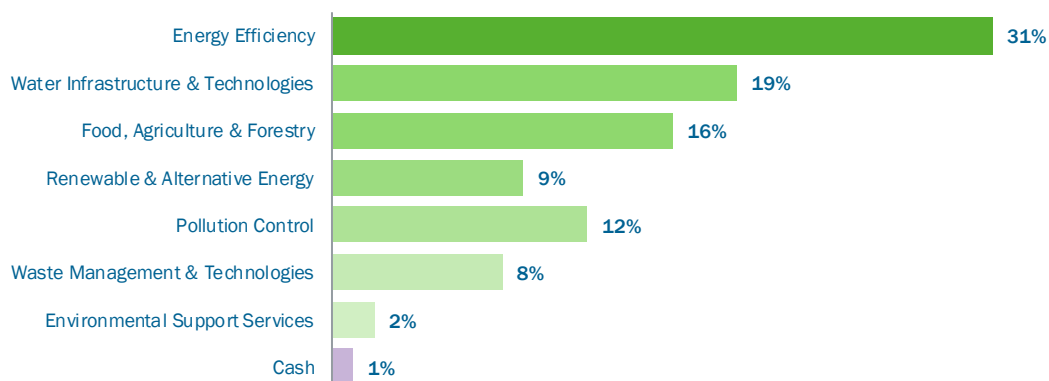
